CALL FOR PRESENTERS

Submit your proposal for the 2024 LED Partnership Workshop! The workshop theme is “Multidimensional Perspectives of the Labor Market.” The workshop will be held from noon – 5pm Eastern on May 14 – 15, with interactive training sessions from noon – 5pm Eastern on Thursday, May 16. Highlight your work among peer data users with your research in topics including, but not limited to: workforce development, economic development, transportation planning, economic analysis, and emergency management.

The LED Partnership is a collaboration between state data agencies and the U.S. Census Bureau to leverage existing data in the development of new sources of economic and demographic



information. The workshop provides insights into these data products and professional development and networking for Labor Market Information directors, data analysts and data providers at state and federal agencies, nonprofit organizations, businesses, and other data users.

The focus of presentations at the workshop is useful utilization of data made possible through the LED Partnership: the Quarterly Workforce Indicators (QWI), the Longitudinal Employer-Household Dynamics (LEHD) Origin-Destination Employee Statistics (LODES), OnTheMap, Job-to-Job Flows (J2J), Post-Secondary Employment Outcomes (PSEO), or Veteran Employment Outcomes (VEO).

PRESENTATION GUIDELINES:

- Visual representations (PowerPoint, maps, graphs, data visualization) and online demonstrations are strongly encouraged.
- Presentations may be posted to the LEHD website and used in promotional materials.
- The LED Partnership reserves the right to edit all submitted presentations for publication on the web site and in the Workshop program.
- The Workshop Program Team will determine the times for the presentation panel.
- Presentations should be approximately 15 minutes in duration, with an additional 10 minutes for questions and answers; a discussant will moderate and encourage discussion of potential and/or similar uses of the LEHD data from the presentations in each session.



SELECTION PROCESS:

The LED Partnership seeks presentations that reflect:

- Case studies, innovations, and best practices using LEHD data
- Integration of LEHD data with other sources
- LEHD-based programs and initiatives that demonstrate measurable impacts and results
- Outstanding success stories

Proposals will be judged on the following criteria:

- Relevance
- Informing decision-making and/or problem solving
- Usefulness to other data users
- Presentations must *feature* the use of Longitudinal Employer-Household Dynamics data, alone or in combination with other data sources.
