


J2J NAICS3 release Monday

PSEO Updates

- We now have over 800 institutions in PSEO
- Added 6 new systems in June 2023
- Added state-level aggregations of earnings (i.e. earnings for graduates from Ohio with a bachelors in engineering)
- Signed 7 new partners in the past year as well



LEHD Origin-Destination Employment Statistics (LODES)



LODES

2020 released in April 2023

- 8.0 version of LODES
- Recast all historical LODES years into 2020 Census blocks

2021 released in November 2023

- All partner states were included (no AK, AR, and MS)
- Folded in Hawaii public sector data
- Improved Quality Assurance/Control methodology

Productionizing LODES and its Challenges

- Inputs can be delayed and can change format
- ECON directorate has brought more resources to bear
- Moving from research to production will improve reliability and allows for a more predictable release cadence

Updated Snapshot available in FSRDC

- Streamlined the documentation (https://lehd.ces.census.gov/data/lehd-snapshot-doc/latest)
- Snapshot will now have an annual release
- Reduced the number of files in the snapshot, but increased the ease of use of those files
- Released 2022 Snapshot last December, with minor effort to update.
- Remains an incredible resource for internal and external researchers!



Application Updates



OnTheMap for Emergency Management

- Released three updates: 4.7, 4.23.1, 4.23.2
- Updated ACS (2017-2021), Decennial (2020), and LODES (2021) tabulations


PSEO Explorer

- Released two updates: one to add data for six new PSEO partners, the other added state aggregations
- Streamlined process of adding new state systems/institutions

BDS Explorer

- Added new BDS (2021) tabulations and normalization functionality
- Added easy access for Federal Regional Commission counties








OnTheMap

- 6.23.1: updated to LODES 2020, 2021 TIGER/Line, transitioned from 2010 Decennial Blocks to 2020 Decennial Blocks
- 6.23.2: added "Previous Geography" to Start tab, improved import functionality, and other small fixes
- 6.23.3: updated 2021 LODES data
- 6.23.5: updated to road reference layer, improved geography import, improved analysis titles and chart labeling
- 6.24.1: redesigned Identify Tool, added firm/worker detail to Summary Report for Area Comparison and Destination Analyses

Enhanced Job Frame Overall Design:

Combined jobs frame

For annual-frequency economic statistics (PSEO, VEO, inequality, future experimental products)

UI covered jobs (LEHD)

LEHD jobs (state UI)

For quarterly-frequency economic statistics, point-in-time employment, job-to-job transitions (QWI, J2J) and FSRDC research

Enhanced annual job frame

W2 jobs

For jobs not covered in state UI or states missing in LEHD frame

W2 jobs (IRS)

Selfemployment jobs (IRS)

SE jobs (IRS 1040 C)

Not covered in either W2 or UI are 1099 gig jobs and self-employed workers



Enhanced Job Frame Future anticipated use cases

Fully national jobs frame covering all wage & salary jobs + gig and self-employment:

- New input data for statistical products like PSEO
- True metro-area statistics (difficult with voluntary state frame as many metro areas cross state boundaries)
- Stable provision of national employment indicators (avoid data delays when many MOUs expire at once)

Better business list comparisons:

Use W2-UI links to improve Census Business Frame, with more timely QCEW information

Could potentially create a quarterly combined frame, allowing for more high-frequency statistics:

• 90% of wage and salary jobs can be matched to quarterly LEHD, could impute the rest



Enhanced Job Frame

Our approach:

Because LEHD usually has highest quality job information if available, our approach is to use LEHD when can, W2 job otherwise UI covered jobs (LEHD)

All LEHD/UI jobs included

- All earnings instead of federal taxable wages
- High-quality industry and geography from QCEW/U2W

W2-only records only

 Add W2 records only as needed to complete the frame

> W2 jobs (IRS)

Enhanced annual job frame

All employer and non-employer self-employment jobs included

Selfemployment jobs (IRS)



Big Frames Updates

- Prototype W2 Frame to be done in October 2024
- Working paper coming out discussing the U2W imputation
- FY2025 will be focused on integrating Frames
- Planning development of a data product about Self-Employment Dynamics



Upcoming application development


- LODES in the Extraction Tool
 - Grab only the blocks and characteristics you want from the raw LODES files





Upcoming application development

- PSEO Explorer
 - Short-term make the tool more mobile friendly
 - Longer-term redesign to allow for:
 - More narrative style
 - More comparisons thanks to additional aggregations
 - Additional entry points based on user profile (student, administrator, counselor)





Upcoming data releases

LODES 2022 coming in Fall 2024

- Arkansas likely to be included and eventually backfilled with missing years (2019-2021)
- Will be added to OnTheMap with 2023 TIGER/Line geovintage

OnTheMap for Emergency Management


- ACS 2019-2023 5-year estimates to be added to the tool in early 2025
- LODES 2022 data added into OTM-EM at the same time

What's Next for PSEO

- 5 new systems to be released in June 2024

Upcoming product development

- Unemployment Insurance Claims (UIEO)
